I gave Marie her keys, and I noticed that there was a guy sitting beside her. He had kind of long hair and was wearing a light-colored disco-type silky shirt, under thirty. She got up for a couple of minutes. I think she made a phone call. Before she came back, she stopped and talked with a couple of friends. I asked, 'Do you want a lift home', and she said, 'No, I have to meet someone'. She walked around the corner out of sight and left. We drove home to my house. I didn't notice the time. I think Candy stayed fifteen minutes to half hour. She called me when she got home."

Q That is the extent of Lenny Paradiso's statement?

A That is Lenny Paradiso's statement.

Q Now, Christine Delisi; do you know her?

A Yes.

Q And she is a friend of the victim?

A Yes, she is.

Q And did she provide -- Miss Delisi make a statement as to what she observed that evening?

A Yes, she did.

Q Would you please read --

A Miss Delisi stated there was several people in the bar. She named four or five names. Christine said she came into the bar approximately 12:30 a.m. She was not wearing a watch. She left her house at midnight and looked at the clock on the way out. She had a hassle with a guy on the way to the Nest --

Q Christine had a hassle?

A Right, and she arrived at the Cardinals Nest at 12:30 a.m., and after she arrived, she said Marie was there. She talked with Marie when she arrived and danced with her for ten or fifteen minutes. They then sat down at the bar. Christine talked with another man at the bar for about ten to fifteen minutes -- kind of confusing to read -- and another unknown male talked with Marie for about five minutes. She stated no one came in and talked with Marie coaxing her to leave: That's her statement according to this, except the identification.

Q Now was this person identified?

A On the 16th of August, 1979, she was shown seven photos -- to Christine -- photos shown to Christine -- I'm sorry; District 7, she was shown eleven photos, and she looked over the photos and discarded

one and stated she knew the person involved. She then picked up the photograph and stated, "That's the man that was sitting at the bar with Marie and walked out with Marie." D

Q Walked out with Marie?

A Yes. D

Q And whether this Christine Delisi -- Did Marie say anything to her about how long she was going to be gone before she --

A To wait, she would be back in, I believe.

Q Marie told Christine that?

A She told her to wait for her; she would be back in fifteen or D
twenty minutes.

Q That was as she was leaving?

A As she was leaving; yes.

Q Now as she was leaving, how was Marie Iannuzzi dressed?

A She was wearing what they refer to as a Danskin -- red Danskin, with a wrap-around skirt, and a scarf.

Q Now the Danskin -- this material -- that was underneath the skirt?

A Yes.

Q She had something over the Danskin?

A Believe she had a skirt of some kind.

Q What about stockings; do you know whether she had stockings on?

A She had blue -- black stockings with a black seam running up the back of them.

Q And this was how she was dressed as she was leaving?
