Annmarie states that she was very close friends with Marie. Sometime during May or June of 1979 she received a call from Marie. She said she was calling from Chris's house (Christine Delisi). Marie was crying and upset. She stated she got so scared. David strangled me tonight. I thought he was going to kill me. Annmarie told her to come and see her. Two days later Marie came to her house. Annmarie said at that time she had strangulation marks on her neck. Christine Delisi was also present at this interview. Christine stated that when Marie came to her house on the night she called Annmarie Christine saw the marks fresh. There were 4 finger marks across her neck and skin was broken. Between 6:00 PM and 7:00 PM when on a Friday Night when Marie arrived at Christine's apartment. Marie stated she had a big fight with her boyfriend and he tried to kill her.
